Our Swedish partner, Association of Tenants of Aros-Gävle region contributes to the HOLICOB project in the following areas:

- gathering deeper understanding of cultural, social and financial knowledge from housing in Bosnia;

- ✓ 4 local and regional social researches – over 1.500 interviewed (students, unemplo- yed and tenants);
- ✓ monitoring housing and living sector related institutional, legislative, economical and fiscal framework in B&H at different administrative levels – updated members, using social media;
- ✓ developing advocacy documents and recommendations for changes in B&H legislation, policies and practices – 2 public hearings and law changes suggestions;
- ✓ 2 advocacy campaigns, including international one "Home for All", demanding legislative and policy implementation in B&H – 16 TV and radio shows, produced 1 docu- mentary reportage;
- ✓ developing members' capacities – 20 workshops, 10 seminars and 3 round tables for nearly 600 participants (advocacy, conflict awareness, gender equality, finances, PR, etc.);
- ✓ raising awareness – 7 publications in two languages (rights, duties and obligations in tenancy; youth solving housing situation; safety and housing);
- ✓ network and cooperation at local, regional and international level – functional informal network of relevant stakeholders in 3 sectors in Tuzla and Sarajevo; developed HOLICOB project methodology; regional fund raising with CSO partners in Western Balkan countries; 27 HOLICOB members participated to 6 study visits (Sweden, EP Brussels)
